NOTICE OF REINVESTMENT FEE COVENANT

Pursuant to the requirements of Utah Code § 57'1-46 (the "Code"), this Notice of Reinvestment Fee Covenant (the "Notice") satisfies the requirements of the Code and serves as record notice for that certain reinvestment fee covenant (the "Covenant")(Article 6, Section 14) that was duly approved and recorded on 29 September, 2016, as Entry No. 12376589 against the real property (the "Property") located in Salt Lake County, Utah, that is described in Exhibit A attached hereto as well as in the First Amendment To The Declaration Of Condominium For Horizon Heights Condominiums, a Planned Unit Development in Salt Lake County, Utah, as recorded on 29 June, 2018, as Entry No. 12801866 in the Salt Lake County Recorder's Office.

BE IT KNOWN TO ALL BUYERS, SELLERS, THEIR REPRESENTATIVES (AGENTS/BROKERS) AND TITLE COMPANIES that:

- 1. The name and address of the beneficiary under the Covenant is Horizon Heights Condominium Owners Association (the "Association"), C/O Desert Edge PM, 9135 S. Monroe Plaza Way #A, Sandy, Utah 84070. When this contact information becomes outdated, contact with the Association can be made through its registered agent. The current registered agent of the Association can be found through the Utah Department of Commerce, Division of Corporations.
- 2. The burden of the Covenant is intended to run with the land (i.e., the Property) and to bind successors in interest and assigns.
- 3. The duration of the Covenant shall be on going until properly amended or eliminated, or until prohibited by operation of law.
- 4. The existence of the Covenant precludes the imposition of an additional reinvestment fee covenant on the burdened property by the Horizon Heights Condominium Owners Association. The Herriman Towne Center Homeowners Association (the "Master Association") can and does charge a reinvestment fee through their covenants for expenses/reserves not related to the expenses/reserves incurred by the Horizon Heights Condominium Owners Association.
- 5. As of the date of this Notice and as duly established by resolution of the Association's Board of Directors, an amount of 0.5% (1/2%) of the value (i.e., the purchase price) of a burdened property shall be charged. The buyer of the burdened property shall pay this amount unless otherwise agreed in writing by the buyer and the seller of the burdened property. This amount shall be in addition to any pro rata share of assessments due and adjusted at settlement.

- 6. The purpose of the amount required to be paid under the Covenant is to maintain and supplement the Reserve Funding requirement as determined by the Reserve Study, the Board of Directors and Utah Code §57-8-7.5 Reserve analysis--Reserve funding.
- 7. The fee requirement of the Covenant is for the benefit of the burdened property, by providing funds for future capital expenditures of the limited common and common areas, and providing a backup for a possible shortfall in the general budget without the use of a Special Assessment or other detrimental financing techniques.


